



St. Olaf Ice Arena Waiver for Participation

Assumption of Risk, Liability and Indemnification

I understand that skating and other activities in an ice arena are inherently dangerous. I understand that by participating in an activity at the St. Olaf Ice Arena (the “Activity”), I am exposing myself, and others, to the risk of accident, illness, injury, or even death, as well as risk of loss, damage, or theft of property. I voluntarily assume all risks related to my participation in this Activity.

In return for participating in the Activity, I, on behalf of myself, my family, estate, heirs, representatives and assigns, hereby release and promise not to sue St. Olaf College, its Board of Regents, its employees, independent contractors, instructors, agents, and representatives, and all other persons and entities (hereinafter “Released Parties”) from any and all present and future claims, demands, actions or causes of action resulting from any personal injury or death, or any loss, damage, or theft of property, resulting from the Activity (hereinafter “Claims”). This waiver and release shall be interpreted to include any Claims relating to skating equipment of my own or of others that I choose to use in the Ice Arena. In addition to the foregoing, I further agree to defend and indemnify the Released Parties from any Claims asserted against them resulting from my participation in the Activity.

I represent that I am medically fit and have received appropriate training to participate in the Activity. I agree that it is my responsibility to inspect and determine whether equipment I use is safe for the Activity. I further agree that I am responsible for any damages sustained to any rental equipment or other St. Olaf property damaged as a result of my participation in the Activity.

If I am the parent or guardian of a minor(s) participating in the Activity, I agree on behalf of myself and my child to discharge the Released Parties from any and all Claims as a result of my child’s participation in the Activity. I further agree to indemnify and hold harmless the Released Parties from all Claims resulting from my child’s participation in the Activity.

In addition to this Waiver for Participation, I have also signed the College’s Agreement for Assumption of Risk, Indemnification, Release, and Consent for Emergency Treatment. This latter agreement applies to all St. Olaf athletic facilities, including the Ice Arena, and is incorporated herein by reference.

I understand that this Waiver, Release of Claims and Indemnification Agreement is intended to be as broad and inclusive as permitted by the laws of the state of Minnesota and I agree that if any portion is held invalid, the remainder of this agreement shall continue in full legal force and effect. I further agree that the venue for any legal proceedings related to my participation in the Activity shall be in the state of Minnesota.
